# Note No. 6 - Statement of Significant Accounting Policies Adopted by the Company and Notes Forming Part of the Accounts

A. Significant Accounting Policies Adopted by the Company:

- Long term Investments are stated at Cost of acquisition. Current Investments are stated at lower of Cost and Fair value.
- Revenues/Income and Costs/Expenditure are generally accounted on accrual basis, as they are earned or
- Grants received towards specific purposes, are credited directly to respective Earmarked Funds. Income earned on utilisation of Earmarked Funds and refund of expenditure incurred out of such funds, are transferred to the respective Earmarked Funds. Corresponding direct expenditure incurred are withdrawn from the respective Earmarked Funds. However, income earned on temporary investments made out of such grants are not allocated to each Earmarked fund
- Funds disbursed out of grants received are treated as utilisation of Foreign Funds and are transferred to Local Books.

Previous year's figures have been regrouped / recast wherever necessary.
